## **Personal precautions**

# Methods and materials for containment and cleaning up

# **Precautions for safe handling**

Avoid inhalation of vapor or mist. Keep away from sources of ignition - No smoking. Take measures to prevent the buildup of electrostatic charge.

## **Conditions for safe storage**

Keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage.
