**4. FIRST-AID GUIDE:****General advice**

**6. ACCIDENTAL RELEASE GUIDE:**

**Personal precautions**

Wear respiratory protection. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Beware of vapors accumulating to form explosive concentrations. Vapors can accumulate in low areas.

**Environmental precautions**

Prevent further leakage or spillage if safe to do so. Do not let product enter drains.

**Methods and materials for containment and cleaning up**

Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and place in container for disposal according to local regulations (see section 12).

**7. HANDLING AND STORAGE:**

**Precautions for safe handling**

Avoid contact with skin and eyes. Avoid inhalation of vapor or mist. Keep away from sources of ignition- No smoking. Take measures to prevent the buildup of electrostatic charge.

**Conditions for safe storage**

Keep container tightly closed in a dry and well-ventilated place. Containers which are opened must be carefully resealed and kept upright to prevent leakage.

Recommended storage temperature: 2 - 8 °C

Light sensitive. Store under inert gas.

**Respiratory protection**
