4. FIRST-AID GUIDE:

Inhalation

If breathing is difficult, remove to fresh air and keep at rest in a position comfortable for breathing. For breathing difficulties, oxygen may be necessary. Call a physician if symptoms develop or persist.

5. FIRE-FIGHTING GUIDE:

Suitable extinguishing media

Water spray, fog, CO2, dry chemical, or alcohol resistant foam.

Unsuitable extinguishing media

Do not use a solid water stream as it may scatter and spread fire.

Specific hazards arising from the chemical

Fire may produce irritating, corrosive and/or toxic gases.

Special protective equipment and precautions for firefighters

Firefighters must use standard protective equipment including flame retardant coat, helmet with face shield, gloves, rubber boots, and in enclosed spaces, SCBA. Structural firefighter's protective clothing will only provide limited protection. Wear self-contained breathing apparatus with a full face piece operated in the positive pressure demand mode when fighting fires.

Firefighting equipment/instructions

6. ACCIDENTAL RELEASE GUIDE:

Personal precautions, protective equipment and emergency procedures

Keep unnecessary personnel away. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them. Eliminate all sources of ignition. Avoid contact with skin or inhalation of spillage, dust or vapor.

Methods and materials for containment and cleaning up

Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for later disposal. Clean surface thoroughly to remove residual contamination.
